

# How to Use Mission Critical Occupation Tags in MHME

Mission Critical Occupation (MCO) Tags allow vacancies to be published to established USAJOBS Agency Branded Search Pages and other specific OPM pages/portal supporting key hiring initiatives (as well as support applicant job searches). Once there is an established page, it's easy to add your announcement to be part of these initiatives.

Start with posting a vacancy as you normally do in the Monster Hiring Management Module. When you get to the Announcement Text step, either select the checkbox for your tag under Mission Critical Occupation Tags or use the dropdown to find a tag under Custom Mission Critical Occupation Tags and click Add.
